Launched in 2006, the Corporate Pro Bono (CPBO) Challenge® initiative enables legal departments to identify, benchmark, and communicate their support for pro bono service. The Challenge sets an aspirational goal that 50 percent of the department, including lawyers and staff, will participate in pro bono annually. 

Since its launch, the CPBO Challenge initiative has grown to more than 190 signatories.




### Industry to Industry

Average participation rate of U.S. lawyers by industry sector from 2023 CPBO Challenge Survey:




## No Department Too Small, or Too Large
