

3M AND CHILDREN'S LAW CENTER OF MINNESOTA WIN 2007 CPBO PRO BONO PARTNER AWARDTM

The legal department of 3M has been selected to receive a national pro bono partnership award for their innovative partnership representing abused and neglected children with Children's Law Center of Minnesota.

Washington, D.C.-based Corporate Pro Bono (CPBO) presented the fifth annual **CPBO Pro Bono Partner Award** at the Annual Pro Bono Institute Seminar/Forumon March 2, 2007 at the Willard Hotel in Washington, D.C. The CPBO Pro Bono Partner Award recognizes unique pro bono partnerships between in-house corporate legal departments, law firms and public interest organizations. Thomas F. Beddow, Staff Vice President, Public Affairs and Government Markets, 3M Company and Gail Chang Bohr of the Children's Law Center accepted the award on behalf of the partner organizations.

Children's Law Center's partnership with 3M Company began in 2000 when 3M invited Children's Law Center to develop a pro bono project with 3M to provide pro bono representation for children in the foster care system. Since then 3M has steadily increased its recruitment of teams of attorneys, paralegals, and support staff to represent children in juvenile court. In addition, 3M hosts Children's Law Center's training programs and assists in the training of volunteer attorneys.

As Gail Chang Bohr, the Executive Director of Children's Law Center, noted "3M lawyers make children's voices heard in the systems that affect them so profoundly."

3M volunteer attorneys meet with the children they represent in the child's own setting in accordance with the ABA Standards for Representation of Abused and Neglected Children. In their role as both counselor and advocate, the attorneys take the time to get to know the child and to explain an often-complex and bewildering process. By researching the available options and explaining those options to their clients, they assist the child in the navigation of the court system.

The source of the Pro Bono Partner award, CPBO is itself a partnership between the Association of Corporate Counsel (ACC) and the Pro Bono Institute at Georgetown University Law Center.
