Each year, Corporate Pro Bono (CPBO) presents the CPBO Pro Bono Partner Awards in honor of innovative collaborative approaches to pro bono work involving in-house legal departments. The awards will be presented on Wednesday, **October 9, 2024**, at the **Pro Bono Institute (PBI) Annual Dinner in New York City** and may be presented to any partnership that includes **at least one legal department and one or more law firms and/or public interest organization partners**. Award winners will be expected to attend the Dinner to accept the Award, and to prepare a video about their partnership.

Award winners are selected based on the following criteria:

- 1) demonstrated impact of the partnership project on its community or target group;
- 2) substantial involvement by in-house lawyers;
- 3) tangible steps toward sustaining the partnership;
- 4) innovative substantive and/or structural (e.g., delivery model) approaches to the effort; and
- 5) addresses a critical legal need and/or particularly vulnerable community/target group.
